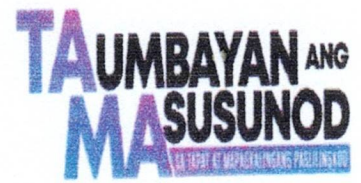


NOW THEREFORE, We, the members of the Bids & Awards Committee, hereby RESOLVE as it is RESOLVED:
